#### FROM BISHOP JOHN STEAD – AMS National Chairman

Supporting those who are working to ensure that the safety of individuals is guaranteed within the church should be a concern of all members of the church community. Indeed, we should go beyond support and commit ourselves to working to create safe church environments.

Being a safe church is not just about protecting children, although much of the focus has been upon this due to the Royal Commission into Institutional Response to Child Sexual Abuse. Being a safe church encompasses safeguarding the well-being of any vulnerable person. A young person (birth to 18) falls within the category of being vulnerable but so too do adults 'whose ability to protect himself or herself from violence, abuse, neglect or exploitation is significantly impaired through physical or mental disability or illness, old age, emotional fragility or distress, or otherwise the reference to being impaired is to being impaired temporarily or indefinitely...' (see the CofE's Clergy Discipline Measure 2016).

The National Church (General Synod and Standing Committee) and your Diocese will have introduced measures to ensure that we are a safe church. One would imagine that everyone would support the principle underlying a Safe Church Environment; it's a 'no-brainer,' of course, we want to be a safe church!

One of the problems which arise is when a church authority asks us to comply with a screening process, which may include a National Police Check, and undertake safe ministry training. After all, we haven't been expected to do these things before! Are you implying that I might do something wrong? Don't you trust me? I'm offended that you would ask me to do this, I've been helping in my church for forty years! These or similar comments are often said.

The problem with the responses above is that the focus has shifted away from ensuring that vulnerable people are safe to be offended that our character has been called into question. The reality is that no one's integrity is being questioned. Instead, we have come to realise that we need to screen all people who are either in leadership roles or exercising a ministry that may include vulnerable people to ensure that we are a safe church. When we start making exceptions we create a pathway that can be taken which can enable abuse.

I hope that all the members of AMS will be advocates for processes that ensure we are a safe church, that members will support those who have the leadership role in implementing the screening and training processes.

# REPORT FROM MAKANG'WA

Greetings from the Amani Center and the Amani Family.

The rains have moved away. We are enjoying sunny days, literally making hay while the sun shines.

The Prince of Peace School. Classes recommenced on Monday, April 9<sup>th</sup>, following the Easter break. The school environment is attractive following the welcome rains. The local roads, which were DREADFUL during the rains have been graded and rolled. The buses will enjoy smooth travel – for a while. We are placing increasing pressure on parents to increase fee contributions. This is meeting with some success. We anticipate further strong improvement following the coming harvest. Do pray for the school. The students are a joy.

DCMP – The Children's Home. The activity has now been renamed, by Government decree. It is now the 'VIABLE MEANS FOR CHILD AID' non-Government

organization. It will be known as VIMECHIA. That is quite a mouthful. In correspondence we shall refer to VIMECHIA (DCMP). That will help until we are 'converted' to the new terminology. I have today learned that Young Ben, who leads this ministry, has been diagnosed with typhoid fever. Keep him in your prayers as he now continues through the recovery phase. Fortunately there are others at the Home who can maintain all activities. On Saturday, April 7<sup>th</sup> I participated



in a meeting of the reconstituted Board of VIMECHIA (DCMP). It was an encouraging meeting. Presently the membership consists of Young Ben, myself, a most competent secretary, a local teacher, the Headmistress of the local Primary School, two local Pastors, the Ward (Regional) Education Coordinator, and a Lay Catechist. This is an impressive group of dedicated people. They



are determined to strengthen local support for this work. The future has many challenges but we are encouraged.

The Amani Center is a picture following the rains. We are struggling to make arrangements to manage the coming harvest (maize, sorghum, millet, sunflower), and to gather and process the greatly increased amount of hay, needed for the long dry



season. We normally retain the grain from the harvest for processing into flour for Prince of Peace and the Children of Peace Preschools. I thought I had this well in hand but have underestimated the facility required to handle it. We are working on it.

In relation to all of this blessing it is evident that we need increased security for the Center.

The key need is the fencing of our main road frontage. Most projects here spend HEAVILY on security fencing

at the

beginning of development. We constructed a GATE, with thorn bush fence. The development of our various activities indicates the pressing need for the fence. We have cattle, pigs, chickens and ducks, the Student House, grape vines and our now producing

coconut trees.

Our dairy bull is a little 'pushy'. We do not want to have an injured child. For this work we need the following:

Twenty Rolls of 2m chain link fencing (15m per roll). \$973.00USD

Fifty Two treated posts. \$490.00USD



Ten rolls of barbed wire.
Cost of clearing the fence line.

\$250.00USD \$130.00USD

If this were a perfect world.....! Well, the Ten Commandments became necessary long ago. Contributions to this need will be most WELCOME.

We have been blessed through the presence of visitors. Kris and Steve Hart, Billings, MT and friend Tito, from northern Tanzania, visited for three days. I knew the Harts through most of my days in Billings. It was such a joy to meet again, here in Tanzania, celebrating the present and recalling wonderful days. Steve is involved with a water project in northern Tanzania.

This was followed by a visit from Pastor Paul Masaka and his lovely wife Shukran. Their marriage took place while I was away last year. I have known Paul for some years as he worked here in preparation for entry into Theological College. He was sponsored through Amani. As you can see Shukran is a beautiful woman. Paul's congregation has grown to the point where they now have

two morning services. The congregation is planning a new building to replace the present structure. I know that people who know Kris Hart will enjoy the photo of Kris joining in the praise, with dance! This was an outstanding celebration at St. John's Church.

Thank you for your support and prayers. May the blessings of God abound towards you.

### QUEENSLAND PROVINCIAL COUNCIL ANNUALCONFERENCE AND A.G.M.

This event was held at St. Peter's, Southport on Saturday 26<sup>th</sup> May, 2018. A total of 52 people attending the meeting including Bishop John Roundhill, Bishop Johnathan Holland and Bishop Danial Deng Abot of South Sudan. Also in attendance were Dean Philip Rongotha and 8 delegates from Honiara in the Solomon Islands.

The Friday evening was an informal Pizza night as delegates arrived at the local motel. Saturday commenced with a breakfast at St. Peter's followed by the morning business session.

**Nine new members** were inducted – from Honiara Frs. John Ashley, Matthias Aula Loji, Noel Sanau, from a new branch at Inala, Brisbane – Neil Holm, Arthur Walker, Douglas Wiskar, Alfred Wreh and Janani Loum and Robert Kake from the Ipswich branch. A big welcome to these new members joining the AMS brotherhood.

**Christian Religious Instruction.** Following an address from the Co-ordinator of CRI for the greater Ipswich area a donation of \$2,000 was approved for this work.

**Bishop's visit to Honiara.** The Council agreed to sponsor a visit by Bishop John Stead to Honiara in 2019.

**Admission of female Priests/Rectors to AMS membership**. It was agreed to alter the Queensland Constitution to permit this change in membership.

**New AMS branches.** A donation of \$1,000 to be granted to new branches when chartered..

**Queensland Council Projects.** Every two years we nominate a Council Project. The current Project "Bush Ministry" is in its second year. A grant of \$4,000 was approved.

**AMS Relief Fund.** The existing Benevolent fund to be altered to the new name – AMS Relief Fund for easier administration. \$4,000 to be transferred to this account bringing the balance to \$4,883.13.

**Bursary for St. Francis Theological College.** It was agreed that our current annual bursary of \$15,000 continue in the years 2019, 2020 and 2021.

**Bishop Daniel Deng Abot's mission in South Sudan and Uganda.** It was agreed to pay for Bishop Daniel's airfares to and from South Sudan. It was also agreed to grant \$3,000 to Bishop Daniel in January, 2019.

**Amani Centre, Tanzania.** A donation of \$3,000 was approved for the Amani Centre, Tanzania to be paid via the Hearts For Africa in Brisbane.

**Domestic Violence in Solomon Islands**. A discussion was held on methods of combating Domestic Violence. The possibilities of a community Centre in Honiara was canvassed and further investigation is to be made before the November Council meeting.

**St. Hugh's, Inala.** A report was received about the storm and flood damage suffered by this church. It was agreed to donate \$5,000 to the parish towards the cost repairs to buildings.

**EASY FRUIT CAKE** from Lisa - Mainly Music co-ordinator, All Saints', Mitcham, Vic. **Ingredients:** - 125gms Butter, 1 Cup of Brown sugar, 3 tsps of Vanilla essence, 1 Egg, 1.25 cups of SR Flour.

3 cups of fruit – can be fresh or dried fruit or a mixture of both. You could include nuts if you wish.

I have used 1 cup of dried dates and 1 can of Goulburn Valley Mangoes 685gm.

Turn oven on to 200C then reduce to 180C.

**Cake mixture:** Melt butter and dried fruit with brown sugar (low heat) until dissolved. Take off heat and cool a little. Mix in egg and flour.

Drain mangoes, slice and place in baking tray then pour cake mixture over the fruit. Place in oven at reduced temperature – cook 20 mins or until sewer comes out clean.


